The treasurer reported that that the League ended the year in the black, despite earlier fears that there might be a deficit.

The budget was passed and the dues for families were raised from \$65 to \$75 dollars.

## Observer Corps Reports

### **Charter Transition Support Committee:**

Lee Cane, Tom Kadgen, and Cindy Bell attended meetings. The committee will meet with Glenn Noonan, Legislative Minority Leader, to discuss his concerns

regarding the Charter transition. Since the Charter Transition Committee seems bogged down, we feel it might be useful to have several members of this committee attend meetings.

**Charter Transition Committee:**

This committee met April 24, 2007. The new deputy clerk Meg Delay was introduced and it was noted that she does research for a group in Albany and will work part-time as deputy starting in three weeks. She will assist in researching various issues pertaining to the Administrative Code. A budget was created to present to the Legislature for their approval including fees to General Code Publishers and a part-time paralegal. NYS has an unfunded \$25,000 grant to assist in transition and Albany officials will be contacted regarding the possibility of funding the grant. Other counties organization charts will be reviewed with a view to creating one for Ulster County. The procedure for writing a code will follow article by article of the current charter. Input that has been solicited from county department heads will be taken into account when writing the Code.

At the meeting with Glenn Noonan, he stated that he was part of the group that approved writing the Charter several years ago and that he supports the Charter concept but he has some concerns regarding its implementation. Transition timelines are of great concern as the Charter will go into effect in just 18 months. He made note of a number of specific areas that contained inconsistencies or concepts that he felt were not well thought out. Discussion included the crucial importance of competence for the

first Administrative Code and administration forming Ulster County's government for the foreseeable future and beyond and also voiced concerns that communications across party lines have faltered and hopes that this is not a permanent trend. Fiscal responsibility for the process must also be tracked for a successful transition with consideration of the tax burden on Ulster County's taxpayers.

**Vote by Mail:**

The committee met April 25 and May 2 and continues to work on a Power Point presentation to outline the procedures, processes, and benefits of a *Vote by Mail* system. Simplicity and clarity are the goals.

**Moderating: School Board Elections**

The League has had a large number of requests for moderating services and has managed to honor almost all, though it is noteworthy that the pool of moderators and timekeepers is now insufficient. ## Local Education Study Begins a New Phase

Exploring the achievement gap between students of different demographic groups in our local schools will be the focus of a continuing discussion by the Education Study Group. Our starting point will be an examination of relevant data in the school report cards, which are produced by the NYS Education Department to inform the people of New York State about the recent performance of public schools.

A constructive conversation will follow in which participants will develop a deeper understanding of the challenges involved in confronting this issue, and the consequences of failing to address it. Author James Baldwin expressed this point succinctly when he wrote, "These are all our children. We will all profit by, or pay for, whatever they become."
