Who is the "Authority"?

- Board of 17 members
- Implement County's Solid Waste Management Plan
- Reduce solid waste disposal in landfills by establishing recycling and reuse programs
- Provide solid waste management services on County-wide basis
- Construct or acquire solid waste management facilities

What's the Problem?



- No disposal capacity in Rockland
- Waste must be transported 640 miles

Rockland Waste Laws

- Rockland County Sanitary Code Article 17
 - Dual stream recycling program in Rockland
 - Generators & haulers must keep each stream separate
- Flow Control Regulations
 - Materials must go to designated facilities

Transfer Stations Hillburn, West Nyack, West Haverstraw

- Consolidate trash and transport to landfills
- \$76 tipping fee
- Transported to Ontario County & Highland Landfills
- Approximately 640 miles round trip
- Anyone can utilize facility

Transferring Waste



Materials Recovery Facility Hillburn, NY

- Accepts recyclables from all generators (residential, business, and institutional)
- Separate recyclables
- Materials marketed to remanufacturing companies
- \$0 tipping fee (Rockland recyclables only)
- Municipalities receive a \$32 rebate/ton
- Cardboard/paper rebate program for haulers
- Authority provides recycling bins to residents

Household Hazardous Waste Facility Pomona, NY

- Accepts household hazardous waste from residents and small businesses
- No fee for residents
- Drive-through service
- Materials recycled/reused
- Other materials disposed of safely
- Open M-F and one weekend day per month
- Historically costs reimbursed 50% by NYSDEC

Yard Waste Composting

- 3 Facilities
- Yard waste banned at landfills
- No charge for residential yard waste
- Bio-degradable leaf bags provided to residents
- Finished compost marketed and given to

municipalities

Cocomposting Facility Hillburn, NY

- Accepts bio-solids (sludge) for composting
- Currently 6 wastewater treatment plants
- Clean wood used for bulking
- Closed-vessel aerobic system
- Creates a high-quality soil amendment
- Marketed to landscapers, sod growers, nurseries, golf courses, etc.






Waste Generation Points
