One of my greatest resolutions for LWVMHR is that we are more present in our local and state governments and that this is noticed! Before the pandemic we had been building that presence, but as with too many things, it faded in 2020-22 and needs rebuilding.

Either way, candidates need to know what running involves, and it's a lot.



Meeting will be 1:45 PM, at Enzo's Ristorante in Kingston.


All members are welcome to join. Bring a friend and discover a new experience with League Members.

legislation on a variety of
issues the League is

particularly likely to focus on election reform/good government work, environmental issues, and equality of opportunity issues, but details will not be available until the 2024 legislative session is underway.

# 2024 Promises Broad Protection for All New Yorkers' Equal Rights

The New York State League of Women Voters is an active partner in the effort to pass a constitutional amendment adding to existing



enumerated
protections
against
discrimination
based on race and
religion.

This amendment would explicitly

prohibit discrimination based on a person's ethnicity, national origin, age, disability, and sex—including their sexual orientation, gender identity, gender expression, pregnancy and pregnancy outcomes, reproductive healthcare and autonomy.

"Voting rights groups said the new law, which takes effect in 2025, will help save taxpayer dollars and prevent voter fatigue by avoiding the need for holding elections every year. It will also lead to increased voter turnout among communities of color, they said.

"This bill will bring more voters into the political process, including young voters and voters of color, and avoid extremely low turnout and unrepresentative results in local elections," Sam Oliker-Friedland, executive director of the Institute for Responsive Government, said in a statement."




## **Field Trip for Southern Tier Members**


Members of the LWVMHR took a road trip to the FDR Presidential Library & Museum in Hyde Park. They went to view Eleanor Roosevelt's personal marked up copy of the Universal Declaration of Human Rights that she helped develop for the United Nation's adoption 75 years ago! Eleanor Roosevelt

(or ER as she is referred to at the National Site) was a member of the League of Women Voters!



Governor Kathy Hochul has signed into law Legislation S.1856-A/A.7640, known as the Birds and Bees Protection Act.





"By signing the Birds and Bees Protection Act, New York is taking a significant stride in protecting our kids, environment and essential pollinators," Governor Hochul said. "This law underscores our commitment to fostering a thriving ecosystem while we prioritize sustainable farming and agricultural practices."

Legislation S.1856-A/A.7640 is a proactive measure to protect pollinators by restricting the use of neonicotinoid pesticides on certain seeds, outdoor ornamental plants, and turf. It allows sufficient time for innovative research on alternatives and the development of more cost-effective products that are less harmful



to the environment. After this period, the use of neonicotinoids will be subject to science-based evaluations and waiver provisions to assist farm and agriculture operations in the transition to this new program.
