The Prez says...

Get ready- It's getting to crunch time in this election season. I'm happy to report that 2020 NYS election reforms are still rolling in.

Most recently, Governor Cuomo has enacted an Executive Order not just permitting drop boxes for absentee ballot



receipt but mandating their use everywhere in the state. They may be placed at the Boards of Elections (BoE) offices, early voting locations or regular polling places, depending on how much local Boards can afford and where they choose to place them for maximum benefit. This 2020 only policy is for those not wanting to send their absentee ballot through the postal service.

A new law for this year allows early absentee ballot requests (more than 30 days before the election) and will allow the BoE to process them now, so they don't become overwhelmed in October. Anyone expecting to vote by absentee is encouraged to send their application online as soon as possible, a very simple process. CLICK HERE to download a NYS absentee ballot application. Ballots will arrive in October.

Once Election Day passes, all absentee ballots will be counted using new technology in Ulster County, rather than the traditional time-consuming hand count. The scanner is much more efficient and BoE staff is looking forward to a speedier, more accurate count this year. Simple ballot errors can be caught and corrected by the voter before election day this year, due to passage of another excellent law. We are hoping many of these policies become permanent after the pandemic passes.

Our League is collaborating more than ever this year with other Leagues and like-minded organizations. We are very careful to keep our nonpartisan stance and do not work with any organization that does not meet our criteria. In my research of local League history, I saw a quote from 1963 by a LWVUS official that struck a chord with me. "We're used to being called Democratic or Republican by members of the opposite party who don't happen to agree with us on a League position." At the time, the Democrats dismissed the LWV as an insiders club. That said, we work with issues only, not parties or candidates.

Our League is co-sponsoring several virtual State Senate candidate events and working on others, though some may not go forward because incumbent candidates seem loath to participate. This trend is becoming more prevalent and makes it difficult for the public to learn about all candidates. LWV rules state that at least two candidates must accept the invitation for an event to go forward.

The LWV has an excellent interactive website, Vote411.org, where voters can find out what's on their ballot, their polling places and candidates' answers to three questions (chosen by LWVNYS) in their own words so people can decide which one is the best fit for their interests and values.

Census follow-up is in full swing and in order to support an accurate count, you might want to reach out to friends, family and acquaintances to make sure they have completed their form. Funding for governmental representation, education and right down to the local fire companies and highway departments depend on accurate counts. Census Update

As this Newsletter posts, you have just over a week to complete your form for you and your household to be counted by the Census. Members of your household need not be



related, nor do they need to be U.S. citizens.

If your residence in the Hudson Valley is your second home, and you were primarily domiciled in this area April 1st, during the pandemic, do complete a survey for this location. It would only be appropriate that Dutchess and Ulster have the funds needed to providing important infrastructure for you in this area. Roads can get quite bumpy here.

Dutchess is doing better at this time with their responses. Let's have a healthy competition to see which County is better at garnering resources for their residents.

If you get a request from the Census, in person, by phone or by a note left at your door - please respond even if you know you filled in the form. Usually it is a check up on something, clarification that will allow your record to go through. Tell your friends not to ignore a Census message even if they think they have done all they need to do.

November Election - dates to note



Voter Registration Deadlines

October 9th - last postmark date accepted for a mailed in registration, registrations must be received by county Board of Elections by October 14th. October 9th - last date to register in

person at the BOE. Those discharged from the military or naturalized citizens after this date have until October 24th to register.

October 14th - last date BOE can accept change of address. A change of address is accomplished by filing an updated voter registration form.

Absentee Ballot Applications

October 27th - last postmark date for a mailed in application for an absentee ballot (although the USPS recommends posting by October 19th.

November 2nd - last day for in person application for an absentee ballot

Note: anyone may apply for an absentee ballot for this upcoming General Election, even if they are not going to be out of town on November 3rd. They can use "temporary illness' due to Covid 19 as a reason.

If you requested an absentee ballot before August 20th (when Gov Cuomo allowed fear of Covid 19 to be a temporary illness) you will need to re-apply. Ballots will not be mailed until late September or October.

Deadlines for Absentee Ballots:

Tuesday November 3rd (Election Day) last day to deliver ballot or postmark ballot (must be received by November 10th, military ballot by November 16th) For more details on absentee ballots CLICK HERE **Remember:** you can vote in person if you have already voted by absentee ballot, the absentee ballot vote will be set aside and the in person vote counted.

Stop Press:

GREAT NEWS FOR ABSENTEE BALLOT VOTERS!

The New York State League has successfully settled their lawsuit to allow voters to address and correct issues with their absentee ballots. New York voters will now be protected from having their ballots thrown out for small technical issues.

For this election, voters will have 5-7 days (depending on the date of receipt of the ballot) to verify their identity and fix any problems with their ballot, after first being notified by the Board of Elections.

ABSENTEE BALLOT BOXES

Governor Cuomo issued an Executive Order mandating that all Boards of Elections must put absentee ballot collection boxes at all polling places, including early polling sites, where voters can place absentee ballots if they do not wish to use the Post Office.

Presidential/Vice Presidential Debates

All debates are expected to begin at 9pm Eastern time and run for 90 minutes without commercial breaks.

October 7th, Wednesday, the Republican and Democratic Vice Presidential candidates will debate in Salt Lake City, Utah.

October 15th, Thursday the second **Presidential** debate will take place in Mlami, FL

October 22nd, Thursday, the third **Presidential** debate will take place in Nashville, TN.

As we approach the voter registration deadline (Oct 9th), our strategy is shifting gears to a broader perspective: having a voter plan in place. We want people to know about their options of early voting, absentee voting, and in-person voting, and the requirements of each option.

We want the homeless population, incarcerated individuals, and other often overlooked populations, to know how they can participate in the political process.

Sojourner Truth and The NYS Women's Suffrage Commission

The seven-foot bronze statue of one of the nation's leading voices for abolition and universal suffrage in the nineteenth century was unveiled at the Walkway Over the Hudson entrance in Highland on August 25th. The Sojourner Truth statue, created by Yonkers sculptor Vinnie Bagwell, includes text, braille and symbols to encourage

viewers to walk around it and study its surface. The folds of her skirt act as a canvas to depict Sojourner's life experiences, including images of a young enslaved mother comforting her child. Despite the challenges of Covid 19, says Dare, the Commission did create a celebration, both of the 19th Amendment which passed 100 years ago this year, but also, in 2017, a celebration of 100 years of New York women having the vote. It was achieved, she says, largely through grass roots efforts and the dedication of a few Commissioners and local

partners, In the process Dare herself learned of some personal connections to those pioneers and got to celebrate 100 years of the League, and edit a history of those 100 years in New York.


