# **Tribute to Justice Ginsburg**



Ruth Bader Ginsburg

Countless words have been written about Ruth Bader Ginsburg. Here are some that are particularly relevant to League members.

Associate Justice Ginsburg's time on the Supreme Court was a culmination of a legal life spent working on demolishing the cultural norms that steered women towards caregiving and

men towards work.

Before being appointed to the Supreme Court she was the chief architect of a campaign against sex-role stereotyping in the law at the ACLU. But she chose cases of discrimination against men to bring to the Supreme Court - then made up of nine men. As a result widowers were allowed social security survivor benefits (previously only granted to women survivors); husbands of military wives were given spousal allowance for the first time; and any man could get the primary caregiver tax deduction, previously only granted to women or divorced or widowed men. Thus she established the principle of equal treatment in the law for women as well as men, that led to the banishment of numerous laws that treated men and women differently based on archaic gender stereotypes.

As Associate Justice she championed both gender and racial equality, supporting gay rights and affirmative action. In 1996 she

wrote the majority opinion that struck down Virginia Military Institute's policy of excluding qualified women candidates only because of their sex, violated the Fourteenth Amendment's Equal Protection. In 2007 her passionate dissent against the ruling that Lilly Ledbetter lost her pay discrimination suit against Goodyear



because her complaint was not filed within 180 days, led to an update of the 1963 Equal Pay Act in 2009. In other cases, Ginsburg defended affirmative action against a legal onslaught, while noting in interviews that she and many other women had benefited from the practice. And of course her famous dissent to Shelby v Holder which gutted the Voting Rights Act, made her a hero to a younger generation who dubbed her "the notorious RBG". We are still waiting for the Legislative branch to repair the damage.

For those of us whose college experience was one of being always one of the few women in a class, Justice Ginsburg's Harvard experience as portrayed in the biopic "On the Basis Of Sex" rings true, though not many of had the experience of handling our own work and taking notes for our sick husband at the same time. It is difficult sometimes to remember, unless you are reminded through movies and the occasional documentary, how different life was for a woman in this leading democracy before Ruth Bader Ginsburg came along.

#### **Not So Fast**



This year of COVID-19 will long be etched in our mind and memories. We can't just wish for this situation to evaporate; we have to cooperate with sound advice based on verifiable data.

And we have to be patient.

Our National League President, Dr. Deborah Ann Turner, advises us that we have to patient in two regards. One: it is almost inevitable that the results of the election will not be known the night of November 3rd. Fears surrounding the virus have prompted an astronomical number of citizens to vote by mail. We have to let the process of counting the ballots play out fairly over time. May the force be with democracy.

Second: Dr. Turner tells us further that "The American people deserve a Supreme Court confirmation process that builds trust in our democracy and ensures an independent judiciary without compromising any more lives." She encourages League members throughout the country to contact their Senators and tell them that this process cannot be rushed in such a difficult time.

Patience. A hard commodity to come by when we're all striving to cope with the extensive difficulties imposed by this dastardly virus. Patience.


Our Voter Services team did several online informational sessions with schools and other groups, pertaining to the importance of making a plan to vote, and the ramifications of

## On The Flip Side



If you're a resident of Dutchess County, be sure to turn your ballot over and vote "YES" on Proposition #1. This reads:

"Shall Dutchess County adopt a local law establishing an Independent Reappointment Commission for the purpose of drawing Dutchess County legislative districts following every decennial census?"

The League stands behind the position that legislative districts should not be drawn by legislators -- rather by a group composed entirely of no elected officials. This system has worked effectively in Ulster County, and we support Dutchess County moving in this direction.

Starting Monday October 19th, Bring Your Own Bag

Because of a lawsuit filed by PolyPak
Industries and others, the original date
of New York State's Department of
Environmental Conservation's ban on
single use plastic bags (March 1st 2020)
was delayed. The judge in the case
ruled on August 20th against the
plaintiffs, and the NYS DEC declared the
ban on single use plastic bags will go
into effect throughout the state on October 19th.



Ulster County, as well as some other regions in NYS, including New York City, already had a ban on single use plastic bags, initiated in Ulster County in July 2019. Because of the coronavirus, the ban was not enforced, but will be throughout the state from Monday October 19th. NYS law says that any establishment charging sales tax may not give a customer a single use carry out plastic bag. Plastic bags used for bulk fruit and vegetable produce and those used by restaurants for food and pharmacies are exempt. Paper bags will be available at a cost of 5 cents per bag (the money goes to the retailer to offset the cost of the paper bags which are more expensive than plastic ones). Customers on supplemental programs such as SNAP and WIC are exempt from the 5 cent fee. All consumers are encouraged to bring their own re-usable bags when shopping.



The state's DEC says New Yorkers currently use an estimated 23 billion plastic bags annually—each for about 12 minutes—and approximately 85 percent of this total ends up in landfills, recycling machines, waterways, and

streets. According to reports, the reaction to Ulster County's

Bring Your Own Bag legislation went pretty smoothly last summer, once people got used to the idea. Now the whole state will have to get used to the idea. For more information about BringYourOwnBagNew York CLICK HERE
