

## LWVMHR Book Club Meeting

We discussed the book "The Legend of Fire Horse Woman" by Jeanne Wakatsuki Houston. It is a novel set against the background of Manzanar, one of the Japanese interment camp in California, during Second World War. It is the story of

Sayo (a letter bride) who comes from Hiroshima to America to wed Hiroshi - the second son of a wealthy Japanese's family. It is an epic novel of courage, war, family, prejudice and love. Sayo was born under the disastrous sign of the Fire Horse. According to Chinese and Japanese mythology, any women born under this sign was destined to have bad luck in life. In order to survive the stigma, they become resilient. They are mostly intelligent, active

and outgoing and persistent in life. Not a bad thing to be. The book is written in simple readable prose but has the characteristic of a Japanese painting - subtle colors in imageries that are barely allusions of descriptions. At times it reads as the author implies - like characters in a Hokusai canvas.

The next book is "Crises of the Republic" by Hannah Arendt. What are the consequences of lying in politics, the reasons for civil disobedience, causes of violence? Do this topic sounds familiar? Join us on **Monday, October 10th, at 1:45pm**, at Enzo's , in Kingston for the discussion.

We are also learning more about Ranked Choice Voting in an effort to get it to be considered by more localities in our area. Since our League was instrumental in establishing a charter in Ulster County in 2006, we are watching carefully as the eleven members of a Charter Revision Commission begin work this month. Our long-time watcher of Ulster government, Tom Kadgen, was appointed to the commission and he urges others to watch in person (or, we hope, on Zoom).

While we mostly watch to make sure no unfortunate changes get made, we recognize that there are a few that might be good. The commission must finish up by July if it hopes to put any changes before the voters in November 2023. The next meetings are Oct 6 and 13 at 5 pm. More info is available at

# League of Women Voters Mid-Hudson Region Supports Student Voting Accessibility



In New York, it has traditionally been hard for college students to vote. Campuses are spilt up into several districts, with polling sites inaccessible to the typical college student who does not own a vehicle. For example, Vassar College has historically been divided into three districts, causing students to have to re-register whenever they switch dorms. At Bard college, the problems were so bad that the school initiated multiple lawsuits against the Dutchess County Board of Elections to make voting more accessible to its students.

Recognizing the difficulties faced by students trying to fulfill their civic responsibilities, New York recently changed its laws regarding poling sites, amending section 4-104 of New York Election Law to require polling sites on many college campuses. It now provides:

Whenever a contiguous property of a college or university


contains three hundred or more registrants who are registered to vote at any address on such contiguous property, the polling place designated for such registrants shall be on such contiguous property or at a nearby location recommended by the college or university and agreed to by the board of elections.

This amendment was made as part of the 2022 budget and, by its terms, requires "the boards of elections to designate polling places pursuant to this act ...[by] August 1, 2022."

Despite the clear language of the law, the League has been informed that the Dutchess County Board of Elections declined to act on Vassar's requests to set up a polling site on campus. Although Vassar has over 1,000 registered voters, clearly meeting the requirements for its own site, no site was in place for the August 23 primaries and special election, and no sites are slated to be there for the General Election in November.

The LWV-MHR will be reaching out to the Dutchess County Board of Elections for an explanation of what seems to be its blatant disregard for the law. Depending on its response, the LWV-MHR may consider taking legal action and will consider joining any action filing by or on behalf of Vassar students to enforce their right to an accessible polling site. Whereas our core mission is to help people vote, we cannot sit idly by when voting rights legislation is ignored. More to follow.
