## UN Update

Women's Rights is one of the League's most important platforms and remains at the forefront today. It's a recurring problem in that many innocent lives struggle today, for an exit from Child Sex Trafficking.

On September 23, 2021, ECPAT USA gave a webinar on: "Protecting Children and Fostering Inclusive Growth in Tourism: New Opportunities as We Mark UN World Tourism Day."

Tourism is an enjoyable event for travelers everywhere; however, one concern with tourism' is Child Sex Trafficking. Since hotels are the first place the child is taken to, It's not easy to spot a child who is in the sex ring, because a person may not know if the child is with a parent or family member and therefore, not easily recognized. These children are taken as young as 12 years old for sex tourism, if the child is under 18 and is coerced to consent, this is considered a crime by International Law. What is even sadder is the young child thinks this may be normal, due to the money they make for the transaction and the false love portrayed.

Child Sex Trafficking slowed during the COVID-19 Pandemic, but with travel starting up again, this will remain an ongoing problem with tourism unless greater action is taken. Should you become suspicious do not hesitate to get involved: https://www.ecpatusa.org/mission

I thank Maura O'Meara for her excellent program organization and the Ulster County BOE Commissioners for sharing their time and knowledge for this professional presentation. There have been so many changes over the last two years that I think even the most knowledgeable of the audience learned something new. This presentation included BOE processes and changes for this year following expiration of last year's emergency executive orders. Some passed into law while others were eliminated. Most information in the video is pertinent for any NYS resident.

All of this year's 2,500 Voter Guides have now found a home and I would like to acknowledge Dare Thompson, Pat Lamanna and Karen Holloway for an exceptional job well done in getting many of the brochures distributed and in front of citizens. Many others contributed their time and efforts toward this end as well. We brought them to all events that we moderated and I sent numerous guides, via post office, to those who asked for them in all three counties. There is a great interest in this year's ballot proposals and we have done everything we can to let people know about them- from Voter Guides to virtual events, Facebook posts and emailed requests for information.

We are still in need of a webmaster for our online presence. This is where I say thank you, once again, to Kathy OConnor, for her continuing support as we find our way. I have reached out to other League leaders to see how they've worked with the new, and now critical, importance of internet connections of all kinds. COVID considerations continue to plague our in-person plans and has made our organization's grassroots nature truly challenging.

I'm excited to report to you that I have been chosen to be one of the LWV delegates to the COP26 UN Climate Summit in Glasgow, Scotland. It's a far more complex process this year with COVID and worldwide issues of critical importance to everyone--- clean air, fresh water and protection from dangerous weather patterns, while remembering the vulnerable among us who pay the highest price for changes in climate. I hope to bring back practical information and workable solutions to share with our membership and local governments to work the problems in a manner that leaves no one behind. ## Environmental Impact - a series by Cindy Bell

In the 1940s, at President Roosevelt's request, the League of Women Voters carried out a nationwide public support campaign to establish the United Nations. President Harry Truman then



invited the League to serve as a consultant to the US delegation, and this was the first organization officially recognized by the UN as a non-governmental organization, or NGO, and retains its observer status to this day.

As a result of the status, the LWVUS will be participating in this year's COP26 in Glasgow, Scotland. Eleven delegates (observers) will be attending along with Robin Tomakian, the League's Chief UN Observer for Climate Change. I am honored and excited to be among the eleven local League representatives invited, from across the US, and will be attending the second week of the conference from November 7th through the end on November 12th!

So what is COP26? It is the 26th UN Climate Change Conference-COP stands for Conference of the Parties and refers to the signatories of the UN Framework Convention on Climate Change (UNFCCC) signed in Rio de Janeiro in 1992. It is a meeting of world leaders to discuss their countries' climate policies and this year they are expected to submit enhance pledges to they national determined contributions agreed upon at the first signing of the Paris Climate Agreement. It was originally planned to take place in Glasgow last November, but the coronavirus pandemic forced a delay until this year.

It begins on October 31st and while there are numerous

delegates and dignitaries attending events inside, there will be more many more holding rallies, marches and other events outside the venue, hoping to influence the delegates for more substantive action. Corporations and advocacy groups will set up shop in a large pavilion to host panels and press conferences. More to come next month!
